## About the Speaker

Agency actions he has successfully challenged include the 2016 Labor Department "fiduciary" rule, the SEC's "proxy access" rule, and MetLife's designation as "too big to fail." He is 8-0 in lawsuits challenging rules of the SEC. Cases he currently is handling include challenges to the FTC's ban on non-compete agreements, the SEC's "climate disclosure" rule, and the latest Labor Department "fiduciary" rule.
